BEGIN ADDENDUM

The City of Alpharetta (City) is changing the request for proposal documents in the following respects.

The following is a list of questions received by the City after December 1, 2025, and through December 8, 2025 at 2:00 PM.

- Q1 Is the City requiring that the selected contractor provide an overlook(s), or bump out(s) on elevated sections of the trail, similar to the one shown on page 184 of the Reference Material? If so, how many and what size are required?
 - a. Overlooks or bump outs along elevated sections of the trail are not required. Proposals incorporating them may be scored higher.
- Q2 RFP 26-107 Reference Materials, Page 3_Fanfare Way Scope of work callouts do not show the recently installed street lighting, conduit, and pull boxes. This street lighting will require removal during the new construction of Fanfare Way, however it is not shown on the Concept drawings to be reinstalled. Please clarify what replacement lighting, conduits, pull boxes the City of Alpharetta would like to have installed along the limits of new or if this is considered a utility and not required to be included in our proposal.
 - a. The lighting in question is owned by Georgia Power and would be considered a utility relocation. The Design-Build Team would still be responsible for coordinating with Georgia Power should any relocation by required.
- Q3 Is there any flexibility in the width of the 20' easement requirement for parcels 2 & 3? We ask because are concerned that there will be a long run (>4,000') through parcels 2 & 3 with no rest / bench seating areas. With the 12' trail width, 2' minimum required shoulders, that leaves a total of 6' (~3' on either side) to tie back into existing grade. Given that a bench seating area would require a 5' minimum depth, it seems unlikely that these could be accommodated without some additional easement area.
 - a. No.
- Q4 Existing Site Conditions: On Fanfiare Rd, if we need to remove the existing lights and light poles, can we save them and reinstall vs supplying new?
 - a. See the response to Q2.
- Q5 Does the owner want/expect to see an inspector continuously present during all construction activities or only at the necessary inspection intervals?
 - What features of work require continuous inspection?
 - What features of work require periodic inspection?
 - a. The City does not expect the Design-Build Team to provide a continuously present inspector. The Design-Build Team will be responsible for testing and inspections in accordance with the Georgia Department of Transportation's Standard Specifications for Construction of Transportation Systems, 2021 Edition. Additionally, the Design-Build Team will be responsible for any special
